- CNW Tune Up Day is Nov 8 at Kent Sullivan's garage.



# 1955 Chevrolet Biscayne GM Concept Car

It's been quite a year, with my attention diverted to the fiberglass restoration of GM's 1955 Motorama showcar, the Biscayne. I don't know how much you know about this car, but aspects of this car's design also foretold some of aspects of the future Corvair. Here's a shot of it at this year's Pebble Beach event, where it was shown re-assembled and running for the first time since being junked in 1959, but still unfinished, since there wasn't enough time before the Beach showing...

Here's a shot of the rear, which shows its future Corvair and '61 Corvette influence. In fact, I used some NOS '60 Corvair taillights from Clark's to complete the rebuild. The rear bumpers and all the bezels are now composite parts, since the originals were all gone. The green isn't paint, but a resin sealer coat, tinted to match the original car's gelcoat.
